2           COMES NOW, Black Mesa Energy, LLC (“Black Mesa”) and respectfully moves the

3 Idaho Public Utilities Commission (“IPUC” or “Idaho Commission”), pursuant to Administrative

4 Rule 31.01.01.56 and Idaho Rules of Civil Procedure 56(a) and (c), to suspend the briefing

5 schedule in the above captioned matter. Said briefing schedule currently calls for Black Mesa to

6 file its opening brief on August 6, 2020, and for Idaho Power to file its reply brief by September

7 3, 2020. Order No. 34715. The parties are currently engaged in discussions that could obviate

8 the need for further briefing. However, those discussions are not anticipated to be conclusive
