On June 3, 2020, Rocky Mountain Power ("Company"), a division of PacifiCorp, applied for consideration of a power purchase agreement ("PPA") with Birch Hydro Company for energy generated by a small hydro facility in Clark County, Idaho ("Facility"). The Facility is a qualifying facility under the Public Utility Regulatory Policies Act of 1978 ("PURPA").

The Commission now sets deadlines for interested persons to comment on the Application, and for the Company to reply.

NOTICE OF APPLICATION

YOU ARE HEREBY NOTIFIED that the Facility has a nameplate capacity of 2.65 megawatts. The PPA contains published non-seasonal, non-levelized avoided cost rates for a 20-year term.

YOU ARE FURTHER NOTIFIED that the Facility has been delivering energy to the Company in accordance with a PURPA contract dated August 21, 1984. By letter dated March 30, 2006, the Company and Birch Hydro Company agreed the existing PURPA contract will expire at midnight on March 31, 2022.

YOU ARE FURTHER NOTIFIED that the Company requests the Application be processed by Modified Procedure. The Company also requests the Commission declare all payments for purchase of energy under the PPA be allowed as prudently incurred expenses for ratemaking purposes.

YOU ARE FURTHER NOTIFIED that the Application is available for public inspection during regular business hours at the Commission's office. These documents are also available on the Commission's web site at www.puc.idaho.gov. Click on the "ELECTRIC" icon, select "Open Cases," and click on the case number as shown on the front of this document.
