I write to object to the proposed merger/acquisition of Avista with a Canadian firm - Hydro One.

It is a statement of extreme concern that Idaho would allow ownership of a regulated utility by a company in another country. There are 3 dams in northern Idaho owned and operated by Avista on significant bodies of water.
