3. Idaho Forest is an electric service customer of the Applicant, taking service under Applicant's Schedule 25-Extra Large General Service-Idaho. Accordingly, Idaho Forest has a direct and substantial interest in this proceeding.

4. Without the opportunity to intervene herein, Idaho Forest would be without adequate means of participation in this proceeding that may have a material impact on its electric rates and terms and conditions of service.

5. Idaho Forest desires to participate in this proceeding with full rights of a party to, if necessary, introduce evidence, cross-examine and participate in hearings or oral argument. The exact quantity of evidence to be introduced cannot be stated at this time, but Idaho Forest's participation will not unduly broaden the issues or cause delay.
