Comment: Honorable PUC members;

I am offering this memo for your consideration regarding the proposed buyout/takeover of my domestic water provider (Eagle Water Co.) by the foreign conglomerate SUEZ WATER.

I offer my opposition to this effect due to the impact this proposed action will have upon me, personally.

I am retired, on a fixed income. I just incurred a \$118 monthly increase in my medical insurance (I receive no government subsidy for assistance, it's all on me) starting January 2019.

The proposed takeover by SUEZ WATER and their threat of a 200% cost increase will result in a financial burden that I don't need (Or want) Can't live without water, so I'll have to determine what I can live WITHOUT....which means fewer dinners at area restaurants, fewer durable goods purchased at local merchants, allowing my lawn to wither in the summer to reduce this cost increase, etc, etc....it becomes a ripple effect. Multiply my situation by hundreds (or thousands) of similar citizens in this impact area, and you can see the economic hammer being slammed down on consumers in the Treasure Valley.

Eagle is thought of as an affluent community (which is partially true) but there are also many non-affluent citizens here.....so you can't dismiss this increase as "affordable" for everyone.

I am aware that City of Eagle is keenly interested in purchasing Eagle Water Co. and they have a first right of refusal clause with EWC which seems to be "overlooked" by EWC and SUEZ WATER for some reason, so I hope that this issue is also addressed. I know that rate increases are inevitable, but I desire that increase to come from local control, not a foreign entity.

Also, please research the track record of SUEZ WATER from other municipalities that lie under their control.....it is not a stellar record to be proud of.

Thank you for reading my concerns and I hope that you make the proper decision in this matter.
