Comment: After reading the testimony for each of the related parties in this case, I do not believe that this sale and purchase is currently in the best interest of the Eagle Water Company, Inc. customers. I also believe that Mr. Thompson's comment of, "The rate structure that SUEZ proposes is intended to reflect projected costs required to correct identified efficiencies over a reasonable time period while minimizing rate-shock," is misaligned. >200% rate increases over 3 years is heavy rate-shock. I don't like the fact that SUEZ is asking to recover the purchase price through rate increases. That directly negatively impacts the Eagle Water Company, Inc. customers like myself, and is just a greedy position. Ms. Cooper also mentions that current SUEZ customers would benefit financially from this acquisition. So we pay excessively more than we have in the past and they pay less--Not so fair. Water is not a luxury--It's a basic necessity. The proposed SUEZ rate increases just don't justify the benefits that they are saying Eagle Water Company, Inc. customers will realize as part of this sale. (ex: I'll pay \$2 for a bag of peanuts, but the bag is not worth paying \$5.) And if the product you're purchasing needs immediate capital improvement, that's the cost of doing business and/or perhaps you should pay a lower purchase price for Eagle Water Company, Inc.

In final, I believe that I and many other Eagle Residents who are customers of Eagle Water Company, Inc. would feel much more comfortable if there was another potential buyer and offer to purchase. Perhaps the City of Eagle Water could present an alternative offer to purchase Eagle Water Company, Inc. This would ensure that the purchase and treatment of current Eagle Water Company, Inc. customers would be closer to being fair.
